THIS COMPARISON SHAKES THE READER'S CONSCIENCE AND REFRAMES THE DEBATE AROUND POVERTY FROM ONE OF CHARITABLE GIVING TO MORAL OBLIGATION.

IMPACT AND CRITICISM OF THE SINGER SOLUTION

CHANGING THE NARRATIVE AROUND CHARITY AND RESPONSIBILITY
