THIS SHIFT MARKS A MATURATION OF FREUD'S THOUGHT, EMPHASIZING THAT INDIVIDUAL MENTAL HEALTH CANNOT BE FULLY COMPREHENDED WITHOUT CONSIDERING THE SOCIAL CONTEXT. THE TENSION BETWEEN PERSONAL DESIRE AND COMMUNAL ORDER IS PRESENTED NOT MERELY AS A PSYCHOLOGICAL ISSUE BUT AS A UNIVERSAL HUMAN PREDICAMENT.

## RELEVANCE TO CONTEMPORARY SOCIETY

IN TODAY'S RAPIDLY CHANGING WORLD, THE THEMES IN CIVILIZATION AND ITS DISCONTENTS TEXT REMAIN STRIKINGLY RELEVANT. # CRITICAL PERSPECTIVES AND DEBATES

THOUGH WIDELY RESPECTED, CIVILIZATION AND ITS DISCONTENTS TEXT HAS ALSO ATTRACTED CRITICISM AND DEBATE.
