MANY HEALTHCARE EMPLOYERS USE ATS SOFTWARE TO SCAN RESUMES FOR SPECIFIC KEYWORDS. INCLUDE TERMS LIKE “OCCUPATIONAL THERAPY,” “PATIENT-CENTERED CARE,” “REHABILITATION,” “THERAPEUTIC INTERVENTIONS,” AND “EVIDENCE-BASED PRACTICE” TO INCREASE YOUR CHANCES OF PASSING AUTOMATED SCREENINGS.

KEEP FORMATTING CLEAN AND PROFESSIONAL

FORMATTING AND STYLE CONSIDERATIONS

THE VISUAL PRESENTATION OF AN OCCUPATIONAL THERAPY RESUME SAMPLE SIGNIFICANTLY INFLUENCES READABILITY AND PROFESSIONAL APPEAL. INCORPORATING SOFT SKILLS AND PERSONAL ATTRIBUTES

WHILE TECHNICAL EXPERTISE IS PARAMOUNT, OCCUPATIONAL THERAPY RESUMES ALSO BENEFIT FROM SHOWCASING INTERPERSONAL SKILLS THAT FACILITATE PATIENT RAPPORT AND TEAMWORK. EMPATHY, PATIENCE, COMMUNICATION, AND ADAPTABILITY ARE CRITICAL SOFT SKILLS THAT EMPLOYERS VALUE. A THOUGHTFULLY CRAFTED RESUME SAMPLE MIGHT INCORPORATE THESE TRAITS WITHIN THE PROFESSIONAL SUMMARY OR UNDER SKILLS, SUPPORTED BY EXAMPLES IN THE WORK HISTORY SECTION.

THE ROLE OF TECHNOLOGY AND ATS OPTIMIZATION

MODERN RECRUITMENT INCREASINGLY INVOLVES ATS SOFTWARE THAT FILTERS RESUMES BEFORE THEY REACH HUMAN EYES. AN
