Giles, 2010-04-08 Entering the Royal Canadian Mounted Police in 1960 with visions of rural police duties, highway patrol or perhaps plain clothes detective work, I ended up in an unanticipated place, completely foreign to my expectations. In 1964, I was inducted into the obscure and secretive world of subversion and counter-espionage investigations. One of the first books I was instructed to read was: *The Theory and Practice of Communism*, hardly the stuff I was interested in. I didn't know much about the Security and Intelligence Branch and I had a lot to learn about Communists, the Reds, Lenin's Lads or whatever they called them. Previously, my closest encounter with anything related to communism was the Cold War bomb shelter at my first Detachment; a Soviet diplomat, driving a Cadillac that I stopped for speeding; and, massive United States troop movements I observed in Los Angeles at the height of the 1962 Cuban Missile Crisis. That showdown between U.S. President John F. Kennedy and Soviet Premier Nikita Khrushchev was probably the closest the World has ever come to all-out nuclear war. That event and the ever-present threats posed by the Cold War convinced me I needed to get serious about the work I was about to embark upon. This book covers the challenge of maintaining pace with the gathering storm of Chinese political and economic espionage, while at the same time coping with the organizational and individual stress of the McDonald Commission inquiries. It also speaks of the complexities of staffing, management responses during these trying times, of careers floundering and some flowering as the new Service, inundated with over-sight, new policies, procedures, restrictions and guidelines, tried to get its feet firmly on the ground. The stigma of "old wine in a new bottle" held sway in a climate of trying to move forward. Then the catastrophe of the 1985 Air India bombing--Canada's 911--complicated matters even further while C.S.I.S. was still in its infancy. The drama seems to be without end as the Phase II report of the Major Commission of Inquiry into the Investigation of the Bombing of Air India Flight 182 has--at the time of this publication--yet to be released. This is a telling memoir of a career in policing, intelligence and counter-espionage in Canada and overseas; in Services in the midst of traumatic organizational change and stress, mixed with inexplicable management tactics and the pride of diplomatic service.

More concerned with Cherokee Christianization than Cherokee civilization, these eleven essays cover the various

stages of cultural confrontation with Christian imperialism. The first section of the book explores the reactions of the Cherokee to the inevitable clash between Christian missionaries and their own religious leaders, as well as their many and varied responses to slavery. In part two, McLoughlin explores the crucial problem of racism that divided the southern part of North America into red, white and black long before 1776 and considers the ways in which the Cherokees either adapted Christianity to their own needs or rejected it as inimical to their identity.

The other three societies were either less differentiated or less socially unified. They formed their constitutional governments thirty to forty years later than the Cherokee and with more internal

political coercion—and, in the Creek case, with less political stability. The formation and stabilization of democratic state governments is a major issue in such contemporary phenomena as political change in Third World nations and the transformation of the governments of Eastern Europe. The four case studies presented in this hook form the basis of a new and powerful theoretical argument for understanding historical patterns of democratic change, political stability, and the relations of political power.

Walker's years in Boston from 1825, his mounting involvement with the Northern black reform movement, and the remarkable underground network used to distribute the Appeal, all reconstructed here, testify to Walker's centrality in the development of American abolitionism and antebellum black activism. Hinks's thorough exegesis of the Appeal illuminates how this document was one of the most startling and incisive indictments of American racism ever written. He shows how Walker labored to harness the optimistic activism of evangelical Christianity and revolutionary republicanism to inspire African Americans to a new sense of personal worth and to their capacity to challenge the ideology and institutions of white supremacy. Yet the failure of Walker's bold and novel formulations to threaten American slavery and racism proved how difficult, if not impossible, it was to orchestrate large-scale and effective slave resistance in antebellum America. *To Awaken My Afflicted Brethren* fathoms for the first time this complex individual and the ambiguous history surrounding him and his world.
