THESE COMPETENCIES ARE VITAL AS INDUSTRIES SHIFT TOWARDS SMART FACTORIES AND CONNECTED SUPPLY CHAINS.

MOREOVER, MSSCUSA'S STRUCTURED APPROACH TO CLT KEY ACTIVITIES FACILITATES SEAMLESS INTEGRATION WITH BROADER WORKFORCE DEVELOPMENT INITIATIVES. COMPANIES CAN MAP THESE KEY ACTIVITIES TO JOB DESCRIPTIONS, PERFORMANCE METRICS, AND CAREER PATHWAYS, THEREBY ENHANCING RECRUITMENT AND RETENTION STRATEGIES.

## PRACTICAL IMPLICATIONS AND BENEFITS OF MASTERING CLT KEY ACTIVITIES
