groups who had no desire to make way for white settlers. The treaty had created a vast frontier for the fledgling nation, and any American settlers pushing west along it were bound to encounter hostile natives. For the most part, the conflicts that followed consisted mostly of the Native Americans suffering defeat in the face of a better-equipped adversary, interspersed with binding treaties, which, on the side of the federal government, proved not very binding at all. Occasionally, however, there arose a Native American leader of such ability that such defeats were temporarily reversed, and Little Turtle, the war chief of the Miami tribe, was one such man.
