FOR INSTANCE, PLATFORMS LIKE NAADAC'S OFFICIAL TRAINING OR THIRD-PARTY PROVIDERS OFTEN OFFER MINNESOTA-SPECIFIC MODULES.

THE DOWNSIDE OF ONLINE COURSES CAN BE HIGHER COSTS AND THE NEED FOR RELIABLE INTERNET ACCESS. CANDIDATES MUST WEIGH THESE FACTORS AGAINST THEIR LEARNING PREFERENCES AND BUDGET.
