THE QUIZ TYPICALLY ASKS PARTICIPANTS ABOUT THEIR STANCE ON IMMIGRATION, ENVIRONMENTAL POLICIES, SOCIAL JUSTICE, NATIONAL SECURITY, AND ECONOMIC PRIORITIES, AMONG OTHER TOPICS. THE PEW RESEARCH CENTER USES CLUSTER ANALYSIS AND OTHER STATISTICAL METHODS TO IDENTIFY PATTERNS WITHIN THE DATA AND CATEGORIZE RESPONDENTS. THE RESULTING TYPOLOGIES ARE THEN NAMED AND DESCRIBED IN DETAIL, REFLECTING THE DOMINANT TRAITS AND PRIORITIES OF EACH GROUP.

IN THE MOST RECENT ITERATIONS, THE TYPOLOGY INCLUDES GROUPS SUCH AS "FAITH AND FLAG CONSERVATIVES," "NEXT GENERATION LEFT," "STRESSED SIDELINERS," AND "OUTSIDER LEFT," AMONG OTHERS. EACH GROUP DIFFERS NOT ONLY IN IDEOLOGY BUT ALSO IN DEMOGRAPHICS, MEDIA CONSUMPTION HABITS, AND POLITICAL ENGAGEMENT LEVELS, OFFERING A MULTIDIMENSIONAL VIEW OF THE ELECTORATE.

FOR INSTANCE, SOME CONSERVATIVE GROUPS PRIORITIZE NATIONAL SECURITY AND TRADITIONAL VALUES, WHILE OTHERS EMPHASIZE ECONOMIC POPULISM AND SKEPTICISM OF GOVERNMENT. ON THE LEFT SIDE, DISTINCTIONS EXIST BETWEEN THOSE MAINLY CONCERNED WITH SOCIAL JUSTICE AND THOSE FOCUSED ON ECONOMIC INEQUALITY.

THIS NUANCED SEGMENTATION HIGHLIGHTS WHY POLITICAL DISCOURSE OFTEN STRUGGLES TO FIND COMMON GROUND. UNDERSTANDING THESE DIVISIONS THROUGH THE TYPOLOGY QUIZ CAN FACILITATE MORE EMPATHETIC AND PRODUCTIVE CONVERSATIONS ABOUT POLICY AND GOVERNANCE.

RECOGNIZING THE PRIORITIES OF EACH GROUP—WHETHER ECONOMIC SECURITY, SOCIAL VALUES, OR GOVERNMENT TRUST—CAN IMPROVE THE EFFECTIVENESS OF CAMPAIGNS AND POLICY INITIATIVES.

ENCOURAGING CIVIC ENGAGEMENT
