MOREOVER, BYPASSING THE LEARNING PROCESS THROUGH DIRECT ANSWER RETRIEVAL COMPROMISES AN EMPLOYEE'S ABILITY TO PERFORM EFFECTIVELY IN REAL-WORLD SCENARIOS, POTENTIALLY EXPOSING THE INSTITUTION TO OPERATIONAL AND REGULATORY RISKS.
