

# WHAT IS THE LEMON LAW IN MARYLAND

IF YOU'VE RECENTLY BOUGHT A CAR AND SUSPECT IT MIGHT BE A "LEMON," KNOWING HOW MARYLAND'S LEMON LAW WORKS CAN SAVE YOU TIME, MONEY, AND FRUSTRATION.

## WHAT EXACTLY IS THE LEMON LAW IN MARYLAND?

IN SIMPLE TERMS, MARYLAND'S LEMON LAW IS A STATE STATUTE THAT OFFERS RECOURSE TO CONSUMERS WHO HAVE PURCHASED OR LEASED NEW VEHICLES WITH SIGNIFICANT DEFECTS THAT IMPAIR THE VEHICLE'S USE, VALUE, OR SAFETY. THESE DEFECTS MUST ARISE WITHIN A CERTAIN TIME FRAME OR MILEAGE LIMIT. IF THE CAR CANNOT BE REPAIRED AFTER A REASONABLE NUMBER OF ATTEMPTS, THE LAW REQUIRES THE MANUFACTURER TO EITHER REPLACE THE VEHICLE OR REFUND THE BUYER.

THE LAW COVERS NEW CARS, TRUCKS, SUVs, AND EVEN SOME LEASED VEHICLES, AND IT ENSURES THAT BUYERS ARE NOT STUCK WITH DEFECTIVE VEHICLES THAT CONTINUOUSLY BREAK DOWN OR HAVE SERIOUS SAFETY CONCERNS. THE LEMON LAW IN MARYLAND IS PART OF THE MARYLAND CONSUMER PROTECTION ACT AND IS ENFORCED BY THE MARYLAND MOTOR VEHICLE ADMINISTRATION (MVA).

## WHO IS PROTECTED UNDER MARYLAND'S LEMON LAW?

MARYLAND'S LEMON LAW PRIMARILY PROTECTS CONSUMERS WHO PURCHASE OR LEASE NEW VEHICLES FOR PERSONAL, FAMILY, OR HOUSEHOLD USE. THIS INCLUDES PASSENGER CARS, MOTORCYCLES, VANS, AND LIGHT TRUCKS. IT'S IMPORTANT TO NOTE THAT THE LAW GENERALLY DOES NOT COVER:

- USED VEHICLES (UNLESS THE DEALER PROVIDES A WRITTEN WARRANTY)
- COMMERCIAL VEHICLES USED PRIMARILY FOR BUSINESS PURPOSES
- VEHICLES WITH DEFECTS CAUSED BY ABUSE, NEGLIGENCE, OR UNAUTHORIZED MODIFICATIONS

## TIME AND MILEAGE LIMITS TO QUALIFY

TO QUALIFY FOR PROTECTION, THE DEFECT MUST OCCUR WITHIN THE EARLIER OF:

- 18,000 MILES ON THE ODOMETER, OR
- 24 MONTHS FROM THE DATE OF VEHICLE DELIVERY TO THE ORIGINAL CONSUMER.

IF A SERIOUS DEFECT ARISES WITHIN THIS PERIOD AND THE MANUFACTURER OR DEALER CANNOT FIX IT AFTER A REASONABLE NUMBER OF REPAIR ATTEMPTS, THE VEHICLE MAY BE CLASSIFIED AS A LEMON UNDER MARYLAND'S LAW.

## HOW DOES THE LEMON LAW PROCESS WORK IN MARYLAND?

UNDERSTANDING THE STEPS INVOLVED IN THE LEMON LAW PROCESS CAN MAKE IT MUCH EASIER TO NAVIGATE IF YOU SUSPECT YOUR VEHICLE IS DEFECTIVE.

## STEP 1: NOTIFYING THE MANUFACTURER

ONCE YOU NOTICE A SIGNIFICANT PROBLEM WITH YOUR VEHICLE, THE FIRST THING TO DO IS NOTIFY THE MANUFACTURER OR THE DEALER. MARYLAND LAW REQUIRES THAT YOU GIVE THE MANUFACTURER A REASONABLE NUMBER OF ATTEMPTS TO REPAIR THE DEFECT. TYPICALLY, THIS MEANS:

- AT LEAST 3 OR 4 REPAIR ATTEMPTS FOR THE SAME DEFECT, OR
- THE VEHICLE IS OUT OF SERVICE FOR A CUMULATIVE TOTAL OF 30 OR MORE CALENDAR DAYS DUE TO REPAIRS.

## STEP 2: DOCUMENTING REPAIRS AND COMMUNICATION

KEEPING DETAILED RECORDS IS CRUCIAL. BE SURE TO COLLECT ALL REPAIR ORDERS, INVOICES, AND CORRESPONDENCE WITH THE DEALER OR MANUFACTURER. THIS DOCUMENTATION WILL SERVE AS EVIDENCE SHOULD YOU NEED TO PURSUE A LEMON LAW CLAIM.

## STEP 3: REQUESTING ARBITRATION OR FILING A CLAIM

IF THE DEFECT PERSISTS AFTER REASONABLE REPAIR ATTEMPTS, MARYLAND CONSUMERS ARE ENCOURAGED TO SEEK ARBITRATION THROUGH THE MARYLAND MOTOR VEHICLE ADMINISTRATION'S LEMON LAW ARBITRATION PROGRAM. THIS PROGRAM OFFERS A FASTER, MORE AFFORDABLE ALTERNATIVE TO COURT LITIGATION.

IF ARBITRATION IS UNSUCCESSFUL OR NOT PURSUED, CONSUMERS MAY FILE A LAWSUIT AGAINST THE MANUFACTURER. IN SUCH CASES, LEGAL ADVICE FROM A LEMON LAW ATTORNEY CAN BE INVALUABLE.

## WHAT REMEDIES DOES MARYLAND'S LEMON LAW PROVIDE?

SHOULD YOUR VEHICLE QUALIFY AS A LEMON UNDER MARYLAND'S LEMON LAW, THE MANUFACTURER IS TYPICALLY REQUIRED TO:

- REPLACE THE DEFECTIVE VEHICLE WITH A COMPARABLE ONE, OR
- REFUND THE PURCHASE PRICE, MINUS A REASONABLE ALLOWANCE FOR USE.

ADDITIONALLY, THE MANUFACTURER MAY BE RESPONSIBLE FOR REIMBURSING THE CONSUMER FOR INCIDENTAL COSTS SUCH AS TOWING, RENTAL CARS, OR REPAIRS RELATED TO THE DEFECT.

## UNDERSTANDING "REASONABLE ALLOWANCE FOR USE"

MARYLAND LAW RECOGNIZES THAT YOU HAVE USED THE VEHICLE BEFORE THE DEFECT BECAME APPARENT. THEREFORE, THE REFUND AMOUNT IS ADJUSTED BASED ON THE MILEAGE DRIVEN BEFORE THE FIRST REPAIR ATTEMPT. THIS CALCULATION ENSURES FAIRNESS FOR BOTH THE CONSUMER AND THE MANUFACTURER.

## COMMON MISCONCEPTIONS ABOUT THE LEMON LAW IN MARYLAND

MANY CONSUMERS HAVE QUESTIONS OR MISUNDERSTANDINGS ABOUT WHAT THE LEMON LAW COVERS. CLEARING UP THESE MISCONCEPTIONS HELPS SET REALISTIC EXPECTATIONS.

## “MY CAR HAS A PROBLEM, SO IT MUST BE A LEMON”

NOT EVERY CAR REPAIR ISSUE QUALIFIES UNDER THE LEMON LAW. MINOR PROBLEMS OR DEFECTS THAT DON'T SIGNIFICANTLY INTERFERE WITH THE VEHICLE'S SAFETY, USE, OR VALUE GENERALLY DON'T MEET THE LEGAL STANDARD FOR A LEMON.

## “THE LEMON LAW COVERS USED CARS”

MARYLAND'S LEMON LAW PRIMARILY PROTECTS NEW VEHICLES. USED CARS ARE NOT COVERED UNLESS THEY COME WITH A WRITTEN WARRANTY THAT IS BREACHED.

## “I CAN AUTOMATICALLY GET A REFUND”

THE PROCESS REQUIRES GIVING THE MANUFACTURER A CHANCE TO FIX THE DEFECT WITHIN REASONABLE REPAIR ATTEMPTS. AUTOMATIC REFUNDS OR REPLACEMENTS ARE NOT GUARANTEED WITHOUT FOLLOWING THE LEGAL STEPS.

## TIPS FOR MARYLAND CONSUMERS DEALING WITH A POTENTIAL LEMON

IF YOU THINK YOU MIGHT HAVE BOUGHT A LEMON, CONSIDER THESE PRACTICAL TIPS:

- **ACT QUICKLY:** REPORT DEFECTS AS SOON AS THEY BECOME APPARENT AND KEEP DETAILED RECORDS.
- **FOLLOW REPAIR INSTRUCTIONS:** TAKE YOUR VEHICLE TO AUTHORIZED DEALERS FOR REPAIRS TO ENSURE YOUR WARRANTY REMAINS VALID.
- **USE THE MVA ARBITRATION PROGRAM:** IT'S A COST-EFFECTIVE WAY TO RESOLVE DISPUTES WITHOUT GOING TO COURT.
- **CONSULT A LEMON LAW ATTORNEY:** EXPERIENCED LAWYERS CAN HELP YOU NAVIGATE THE PROCESS AND MAXIMIZE YOUR CHANCES OF A FAVORABLE OUTCOME.

## WHY KNOWING MARYLAND'S LEMON LAW MATTERS

# FREQUENTLY ASKED QUESTIONS

## WHAT IS THE PURPOSE OF THE LEMON LAW IN MARYLAND?

THE LEMON LAW IN MARYLAND IS DESIGNED TO PROTECT CONSUMERS WHO PURCHASE OR LEASE NEW MOTOR VEHICLES THAT HAVE SIGNIFICANT DEFECTS AFFECTING THEIR USE, VALUE, OR SAFETY, PROVIDING REMEDIES IF THE MANUFACTURER CANNOT FIX THE PROBLEM AFTER A REASONABLE NUMBER OF ATTEMPTS.

## WHICH VEHICLES ARE COVERED UNDER MARYLAND'S LEMON LAW?

MARYLAND'S LEMON LAW PRIMARILY COVERS NEW PASSENGER VEHICLES, INCLUDING CARS, SUVs, AND LIGHT TRUCKS PURCHASED OR LEASED IN THE STATE. IT GENERALLY DOES NOT COVER USED VEHICLES OR MOTORCYCLES.

## HOW MANY REPAIR ATTEMPTS MUST OCCUR BEFORE A VEHICLE QUALIFIES UNDER MARYLAND'S LEMON LAW?

IN MARYLAND, A VEHICLE TYPICALLY QUALIFIES UNDER THE LEMON LAW IF THE MANUFACTURER OR ITS AUTHORIZED DEALER HAS MADE AT LEAST FOUR ATTEMPTS TO REPAIR THE SAME DEFECT OR IF THE VEHICLE HAS BEEN OUT OF SERVICE FOR 30 OR MORE CALENDAR DAYS DUE TO REPAIRS.

## WHAT REMEDIES ARE AVAILABLE TO CONSUMERS UNDER THE MARYLAND LEMON LAW?

IF A VEHICLE QUALIFIES AS A 'LEMON,' CONSUMERS IN MARYLAND MAY BE ENTITLED TO A REPLACEMENT VEHICLE OR A FULL REFUND OF THE PURCHASE PRICE, INCLUDING TAXES, FEES, AND OTHER RELATED COSTS, MINUS A REASONABLE ALLOWANCE FOR USE.

## HOW LONG DO CONSUMERS HAVE TO FILE A LEMON LAW CLAIM IN MARYLAND?

CONSUMERS IN MARYLAND MUST FILE A LEMON LAW CLAIM WITHIN ONE YEAR AFTER THE EXPIRATION OF THE MANUFACTURER'S EXPRESS WARRANTY OR WITHIN TWO YEARS FROM THE DATE OF ORIGINAL DELIVERY OF THE VEHICLE, WHICHEVER COMES FIRST.

UNDERSTANDING THE NUANCES OF THIS LAW IS ESSENTIAL FOR CONSUMERS NAVIGATING THE COMPLEXITIES OF AUTOMOTIVE WARRANTIES AND MANUFACTURER RESPONSIBILITIES. THIS ARTICLE PROVIDES A COMPREHENSIVE ANALYSIS OF WHAT IS THE LEMON LAW IN MARYLAND, HOW IT FUNCTIONS, AND WHAT CONSUMERS SHOULD KNOW TO ASSERT THEIR RIGHTS EFFECTIVELY.

## WHAT IS THE LEMON LAW IN MARYLAND?

THE MARYLAND LEMON LAW, FORMALLY KNOWN AS THE MARYLAND VEHICLE LEMON LAW, AIMS TO PROTECT CONSUMERS WHO PURCHASE OR LEASE NEW MOTOR VEHICLES THAT DEVELOP SUBSTANTIAL DEFECTS IMPAIRING THEIR USE, VALUE, OR SAFETY.

THE LAW APPLIES SPECIFICALLY TO NEW CARS, TRUCKS, MOTORCYCLES, AND MOTORHOMES THAT HAVE SERIOUS MECHANICAL OR STRUCTURAL PROBLEMS COVERED BY THE MANUFACTURER'S WARRANTY.

UNDER THIS STATUTE, IF A VEHICLE CANNOT BE REPAIRED AFTER A REASONABLE NUMBER OF ATTEMPTS WITHIN THE WARRANTY PERIOD, THE CONSUMER IS ENTITLED TO A REPLACEMENT VEHICLE OR A REFUND OF THE PURCHASE PRICE, MINUS A REASONABLE ALLOWANCE FOR USE. THE LAW BALANCES PROTECTING CONSUMERS WHILE PROVIDING MANUFACTURERS WITH A FAIR OPPORTUNITY TO REPAIR DEFECTS.

## SCOPE AND ELIGIBILITY

THE LEMON LAW IN MARYLAND APPLIES ONLY TO NEW VEHICLES PURCHASED OR LEASED IN THE STATE. IT COVERS VEHICLES THAT ARE STILL UNDER THE MANUFACTURER'S ORIGINAL WARRANTY AND EXCLUDES USED CARS OR VEHICLES SOLD "AS-IS." TO QUALIFY, THE DEFECT MUST SUBSTANTIALLY IMPAIR THE VEHICLE'S USE, VALUE, OR SAFETY, AND THE CONSUMER MUST REPORT THE ISSUE WITHIN THE WARRANTY PERIOD, TYPICALLY ONE OR TWO YEARS DEPENDING ON THE MANUFACTURER.

MARYLAND'S LEMON LAW ALSO REQUIRES THAT THE CONSUMER GIVE THE MANUFACTURER OR AN AUTHORIZED DEALER A REASONABLE NUMBER OF ATTEMPTS TO REPAIR THE DEFECT. WHAT CONSTITUTES A "REASONABLE NUMBER" IS GENERALLY DEFINED AS:

- AT LEAST THREE REPAIR ATTEMPTS FOR THE SAME ISSUE.
- A CUMULATIVE TOTAL OF 30 OR MORE DAYS OUT OF SERVICE DUE TO REPAIRS.
- ONE UNSUCCESSFUL REPAIR ATTEMPT IF THE DEFECT IS LIKELY TO CAUSE SERIOUS INJURY OR DEATH.

IF THESE CONDITIONS ARE MET AND THE PROBLEM PERSISTS, THE CONSUMER MAY PURSUE A LEMON LAW CLAIM.

## HOW DOES MARYLAND'S LEMON LAW COMPARE NATIONALLY?

CONSUMER PROTECTION LAWS LIKE LEMON LAWS VARY SIGNIFICANTLY ACROSS STATES. MARYLAND'S LEMON LAW SHARES COMMON FEATURES WITH OTHER STATES BUT ALSO HAS UNIQUE PROVISIONS THAT INFLUENCE HOW CLAIMS ARE HANDLED.

FOR EXAMPLE, CALIFORNIA'S LEMON LAW IS ONE OF THE MOST COMPREHENSIVE IN THE COUNTRY, COVERING BOTH NEW AND USED VEHICLES UNDER CERTAIN CONDITIONS AND OFFERING BROADER CONSUMER REMEDIES. MARYLAND'S LAW, WHILE ROBUST, IS MORE RESTRICTIVE IN ITS APPLICATION, FOCUSING PRIMARILY ON NEW VEHICLES AND REQUIRING STRICT ADHERENCE TO WARRANTY CLAIM TIMELINES.

ADDITIONALLY, THE TIMEFRAME FOR FILING CLAIMS AND THE DEFINITION OF "REASONABLE REPAIR ATTEMPTS" CAN DIFFER. MARYLAND'S PROVISION OF 30 CUMULATIVE DAYS OUT OF SERVICE IS COMPARABLE TO OTHER STATES BUT MAY BE SHORTER OR LONGER THAN IN NEIGHBORING JURISDICTIONS LIKE VIRGINIA OR PENNSYLVANIA.

## CONSUMER RESPONSIBILITIES UNDER MARYLAND'S LEMON LAW

WHILE THE LEMON LAW PROTECTS BUYERS, IT ALSO PLACES SPECIFIC RESPONSIBILITIES ON THEM TO ENSURE A SMOOTH RESOLUTION:

1. **PROMPT REPORTING:** CONSUMERS MUST PROMPTLY REPORT DEFECTS TO THE DEALER OR MANUFACTURER DURING THE WARRANTY PERIOD.

2. **DOCUMENTATION:** KEEPING DETAILED RECORDS OF REPAIR VISITS, COMMUNICATIONS, AND REPAIR ORDERS IS CRITICAL FOR SUBSTANTIATING CLAIMS.
3. **REASONABLE REPAIR ATTEMPTS:** BUYERS MUST ALLOW THE DEALER OR MANUFACTURER A REASONABLE NUMBER OF CHANCES TO FIX THE PROBLEM.
4. **COMPLIANCE WITH NOTICES:** WHEN THE MANUFACTURER OFFERS A REPLACEMENT OR REFUND, THE CONSUMER MUST COMPLY WITH THE TERMS TO CONCLUDE THE CLAIM.

FAILURE TO MEET THESE OBLIGATIONS MAY RESULT IN THE LOSS OF LEMON LAW PROTECTIONS, EMPHASIZING THE IMPORTANCE OF VIGILANCE AND ORGANIZATION FOR AFFECTED CONSUMERS.

## LEGAL REMEDIES AND PROCEDURES

MARYLAND'S LEMON LAW PROVIDES A STRUCTURED PROCESS FOR CONSUMERS SEEKING RELIEF:

### REPLACEMENT OR REFUND

IF THE VEHICLE QUALIFIES AS A LEMON, THE MANUFACTURER IS OBLIGATED TO:

- REPLACE THE DEFECTIVE VEHICLE WITH A COMPARABLE NEW VEHICLE, OR
- REFUND THE FULL PURCHASE PRICE, MINUS A REASONABLE ALLOWANCE FOR THE CONSUMER'S USE PRIOR TO THE DISCOVERY OF THE DEFECT.

THE ALLOWANCE FOR USE IS TYPICALLY CALCULATED BASED ON MILEAGE AND THE VEHICLE'S FAIR MARKET VALUE, ENSURING FAIRNESS TO BOTH PARTIES.

### ARBITRATION AND LITIGATION

BEFORE PURSUING LITIGATION, CONSUMERS OFTEN ENGAGE IN AN ARBITRATION PROCESS PROVIDED BY THE MARYLAND MOTOR VEHICLE ADMINISTRATION (MVA). ARBITRATION IS A LESS FORMAL, QUICKER, AND LESS COSTLY METHOD TO RESOLVE DISPUTES WITHOUT GOING TO COURT.

IF ARBITRATION DOES NOT YIELD A SATISFACTORY OUTCOME, CONSUMERS RETAIN THE RIGHT TO FILE A LAWSUIT. MARYLAND'S LEMON LAW INCLUDES PROVISIONS FOR ATTORNEY'S FEES AND COSTS IF THE CONSUMER PREVAILS, WHICH CAN BE AN IMPORTANT INCENTIVE FOR MANUFACTURERS TO SETTLE CLAIMS FAIRLY.

### TIME LIMITS

THE LEMON LAW REQUIRES CLAIMS TO BE FILED WITHIN TWO YEARS FROM THE DATE THE CONSUMER FIRST REPORTED THE DEFECT TO THE MANUFACTURER OR WITHIN THE WARRANTY PERIOD, WHICHEVER IS LONGER. THIS STATUTE OF LIMITATIONS ENSURES TIMELY RESOLUTIONS AND PREVENTS STALE CLAIMS.

# CHALLENGES AND CONSIDERATIONS FOR CONSUMERS

WHILE THE LEMON LAW IN MARYLAND OFFERS SIGNIFICANT PROTECTIONS, THERE ARE CHALLENGES THAT CONSUMERS SHOULD BE AWARE OF:

## STRICT CRITERIA FOR ELIGIBILITY

NOT ALL DEFECTS QUALIFY UNDER THE LEMON LAW. MINOR OR COSMETIC ISSUES TYPICALLY DO NOT MEET THE THRESHOLD OF "SUBSTANTIAL IMPAIRMENT." THIS CAN LIMIT THE APPLICABILITY OF THE LAW FOR CERTAIN BUYERS WITH LESS SEVERE PROBLEMS.

## BURDEN OF PROOF

CONSUMERS BEAR THE BURDEN OF PROVING THAT THE VEHICLE IS A LEMON, WHICH INVOLVES DEMONSTRATING THAT THE DEFECT SUBSTANTIALLY IMPAIRS THE VEHICLE AND THAT REASONABLE REPAIR ATTEMPTS HAVE FAILED. THIS PROCESS CAN BE COMPLEX AND MAY REQUIRE EXPERT EVALUATIONS.

## MANUFACTURER COOPERATION

MANUFACTURERS ARE OFTEN MOTIVATED TO AVOID LEMON LAW CLAIMS DUE TO THE FINANCIAL AND REPUTATIONAL COSTS. HOWEVER, SOME MAY BE RESISTANT OR SLOW TO RESOLVE CLAIMS, NECESSITATING PATIENCE AND PERSISTENCE FROM CONSUMERS.

## ADDITIONAL CONSUMER PROTECTIONS IN MARYLAND

BEYOND THE LEMON LAW, MARYLAND CONSUMERS BENEFIT FROM OTHER LEGAL SAFEGUARDS RELATED TO VEHICLE PURCHASES, INCLUDING:

- **WARRANTY RIGHTS:** MARYLAND ENFORCES THE FEDERAL MAGNUSON-MOSS WARRANTY ACT, WHICH PROTECTS CONSUMERS AGAINST DECEPTIVE WARRANTY PRACTICES.
- **USED VEHICLE PROTECTIONS:** WHILE THE LEMON LAW DOES NOT GENERALLY COVER USED CARS, MARYLAND LAW REQUIRES DEALERS TO DISCLOSE KNOWN DEFECTS AND PROVIDES LIMITED REMEDIES FOR CERTAIN SITUATIONS.
- **DEALER REGULATIONS:** THE MARYLAND MOTOR VEHICLE ADMINISTRATION MONITORS DEALER PRACTICES TO PREVENT FRAUD AND UNFAIR SALES TACTICS.

THESE COMPLEMENTARY PROTECTIONS HELP CREATE A MORE TRANSPARENT AND ACCOUNTABLE MARKETPLACE FOR VEHICLE BUYERS.

## PRACTICAL TIPS FOR MARYLAND VEHICLE BUYERS

TO MINIMIZE THE RISK OF ENCOUNTERING LEMON LAW ISSUES, CONSUMERS SHOULD CONSIDER THE FOLLOWING:

- **RESEARCH:** INVESTIGATE VEHICLE RELIABILITY RATINGS AND CONSUMER REVIEWS BEFORE PURCHASE.
- **INSPECTION:** HAVE THE VEHICLE INSPECTED BY A TRUSTED MECHANIC UPON DELIVERY.
- **DOCUMENTATION:** MAINTAIN A THOROUGH RECORD OF ALL SERVICE AND REPAIR WORK PERFORMED.
- **PROMPT ACTION:** REPORT DEFECTS AND SEEK REPAIRS IMMEDIATELY TO PRESERVE RIGHTS UNDER THE LEMON LAW.
- **LEGAL CONSULTATION:** CONSULT AN ATTORNEY EXPERIENCED IN LEMON LAW CASES IF PROBLEMS PERSIST.

BEING PROACTIVE CAN SIGNIFICANTLY EASE THE PROCESS AND IMPROVE OUTCOMES FOR CONSUMERS FACING DEFECTIVE VEHICLES.
