## WHAT IS EITC DUE DILIGENCE TRAINING?

THE TRAINING COVERS THE LEGAL OBLIGATIONS PREPARERS MUST FOLLOW, METHODS TO VERIFY CLIENT INFORMATION, AND WAYS TO AVOID COMMON ERRORS THAT CAN TRIGGER AUDITS OR PENALTIES.

THIS TRAINING TYPICALLY INCLUDES:

- UNDERSTANDING THE ELIGIBILITY CRITERIA FOR EITC

## WHY IS EITC DUE DILIGENCE TRAINING ESSENTIAL?

THE EARNED INCOME TAX CREDIT IS ONE OF THE MOST VALUABLE CREDITS AVAILABLE TO LOW TO MODERATE-INCOME WORKERS AND FAMILIES. HOWEVER, DUE TO ITS COMPLEXITY, IT HAS ALSO BEEN ASSOCIATED WITH A HIGH RATE OF IMPROPER PAYMENTS. THIS IS WHERE EITC DUE DILIGENCE TRAINING BECOMES VITAL.

- MEET IRS DOCUMENTATION STANDARDS

# **SAFEGUARDING TAXPAYERS**

TAXPAYERS RELY ON THEIR PREPARERS TO FILE ACCURATE RETURNS AND MAXIMIZE THEIR REFUNDS WITHIN THE BOUNDS OF THE LAW. PROPER TRAINING EQUIPS PREPARERS TO IDENTIFY ELIGIBILITY ACCURATELY, WHICH PREVENTS TAXPAYERS FROM FACING AUDITS OR OWING BACK TAXES DUE TO INCORRECT CLAIMS.

## **ENHANCING PROFESSIONAL CREDIBILITY**

COMPLETING EITC DUE DILIGENCE TRAINING SIGNIFIES PROFESSIONALISM AND EXPERTISE. TAX PREPARERS WHO INVEST IN THIS TRAINING CAN DIFFERENTIATE THEMSELVES IN A COMPETITIVE MARKET BY PROVIDING RELIABLE AND COMPLIANT SERVICES.

## **CORE COMPONENTS OF EITC DUE DILIGENCE TRAINING**

- COLLECTING APPROPRIATE DOCUMENTATION SUCH AS W-2s, 1099s, BIRTH CERTIFICATES, AND SOCIAL SECURITY NUMBERS
- PROPERLY COMPLETING AND RETAINING FORM 8867
- UNDERSTANDING HOW LONG TO KEEP RECORDS IN CASE OF IRS INQUIRIES

THESE PRACTICES ARE ESSENTIAL FOR SUBSTANTIATING CLAIMS IN THE EVENT OF AN AUDIT.

### **3. COMPLETING FORM 8867**

FORM 8867, PAID PREPARER'S DUE DILIGENCE CHECKLIST, IS A MANDATORY FORM THAT MUST ACCOMPANY TAX RETURNS CLAIMING EITC. TRAINING TEACHES HOW TO FILL OUT THIS FORM ACCURATELY, ENSURING THE PREPARER HAS ASKED ALL NECESSARY QUESTIONS AND PERFORMED THE REQUIRED CHECKS.

### **4. IDENTIFYING RED FLAGS AND AVOIDING FRAUD**

THE IRS PROVIDES GUIDANCE ON COMMON RED FLAGS THAT MAY INDICATE ERRORS OR FRAUDULENT CLAIMS. TRAINING HELPS PREPARERS RECOGNIZE SUCH INDICATORS, INCLUDING:

- DISCREPANCIES IN INCOME REPORTING

## WHO NEEDS TO COMPLETE EITC DUE DILIGENCE TRAINING?

EITC DUE DILIGENCE TRAINING IS MANDATORY FOR ALL PAID TAX PREPARERS WHO PREPARE OR ASSIST IN PREPARING FEDERAL TAX RETURNS THAT INCLUDE THE EARNED INCOME TAX CREDIT. THIS INCLUDES:

- COMMERCIAL TAX PREPARATION FIRMS AND INDIVIDUAL PREPARERS

FAILURE TO COMPLETE THE TRAINING CAN RESULT IN PENALTIES AND LOSS OF ELIGIBILITY TO PREPARE EITC CLAIMS.

## HOW OFTEN IS THE TRAINING REQUIRED?

THE IRS REQUIRES TAX PREPARERS TO COMPLETE EITC DUE DILIGENCE TRAINING ANNUALLY. THIS ENSURES THAT PREPARERS STAY UPDATED WITH ANY CHANGES TO TAX LAWS, CREDIT ELIGIBILITY, AND COMPLIANCE REQUIREMENTS.

- **STAY UPDATED:** TAX LAWS CAN CHANGE, SO MAKE IT A HABIT TO REVIEW IRS UPDATES AND REFRESHER MATERIALS THROUGHOUT THE YEAR.
- **USE TECHNOLOGY:** LEVERAGE TAX PREPARATION SOFTWARE THAT SUPPORTS DUE DILIGENCE CHECKLISTS AND ELECTRONIC RECORD-KEEPING.
- **TRAIN YOUR TEAM:** IF YOU RUN A FIRM, ENSURE ALL STAFF MEMBERS INVOLVED IN PREPARING EITC CLAIMS COMPLETE THE TRAINING.

## WHERE TO FIND EITC DUE DILIGENCE TRAINING

- **\*\*VOLUNTEER PROGRAMS:\*\*** FOR VITA VOLUNTEERS, TRAINING IS PROVIDED AS PART OF PROGRAM REQUIREMENTS.

CHOOSING A REPUTABLE SOURCE ENSURES THE CONTENT IS CURRENT AND MEETS IRS STANDARDS.

## WHAT IS EITC DUE DILIGENCE TRAINING?

EITC DUE DILIGENCE TRAINING IS A MANDATORY EDUCATIONAL PROGRAM FOR TAX PREPARERS TO ENSURE THEY COMPLY WITH IRS REGULATIONS WHEN CLAIMING THE EARNED INCOME TAX CREDIT (EITC) ON BEHALF OF TAXPAYERS.

## WHO IS REQUIRED TO COMPLETE EITC DUE DILIGENCE TRAINING?

ANY TAX PROFESSIONAL WHO PREPARES OR ASSISTS IN PREPARING FEDERAL TAX RETURNS THAT CLAIM THE EITC MUST COMPLETE THE EITC DUE DILIGENCE TRAINING ANNUALLY TO MEET IRS REQUIREMENTS.

## WHAT TOPICS ARE COVERED IN EITC DUE DILIGENCE TRAINING?

THE TRAINING COVERS IRS RULES FOR EITC ELIGIBILITY, PROPER DOCUMENTATION AND RECORDKEEPING, HOW TO AVOID COMMON ERRORS, AND THE LEGAL RESPONSIBILITIES OF TAX PREPARERS.

## HOW OFTEN MUST EITC DUE DILIGENCE TRAINING BE COMPLETED?

## WHAT ARE THE CONSEQUENCES OF NOT COMPLETING EITC DUE DILIGENCE TRAINING?

FAILURE TO COMPLETE THE TRAINING CAN RESULT IN PENALTIES, INCLUDING MONETARY FINES AND SUSPENSION FROM PREPARING RETURNS THAT CLAIM THE EITC.

## WHERE CAN TAX PREPARERS ACCESS EITC DUE DILIGENCE TRAINING?

THE IRS PROVIDES FREE EITC DUE DILIGENCE TRAINING MODULES ONLINE THROUGH THE IRS WEBSITE, AND SOME THIRD-PARTY ORGANIZATIONS ALSO OFFER APPROVED TRAINING COURSES.

## DOES EITC DUE DILIGENCE TRAINING INCLUDE A CERTIFICATION EXAM?

YES, MOST EITC DUE DILIGENCE TRAINING PROGRAMS INCLUDE AN EXAM THAT TAX PREPARERS MUST PASS TO DEMONSTRATE THEIR UNDERSTANDING OF EITC RULES AND REQUIREMENTS.

## HOW DOES EITC DUE DILIGENCE TRAINING BENEFIT TAXPAYERS?

AS THE IRS CONTINUES TO EMPHASIZE THE IMPORTANCE OF ACCURATE REPORTING AND COMPLIANCE, THIS SPECIALIZED TRAINING AIMS TO EQUIP TAX PREPARERS WITH THE KNOWLEDGE AND TOOLS NECESSARY TO MINIMIZE ERRORS AND PREVENT FRAUDULENT CLAIMS. THIS ARTICLE EXPLORES THE CRITICAL ASPECTS OF EITC DUE DILIGENCE TRAINING, ITS REGULATORY BACKGROUND, KEY FEATURES, AND ITS IMPACT ON TAXPAYER PROTECTION AND TAX PREPARATION PRACTICES.

# THE REGULATORY FRAMEWORK BEHIND EITC DUE DILIGENCE TRAINING

THE INCEPTION OF EITC DUE DILIGENCE REQUIREMENTS TRACES BACK TO THE PROTECTING AMERICANS FROM TAX HIKES (PATH) ACT OF 2015. THIS LEGISLATION IMPOSED MANDATORY DUE DILIGENCE OBLIGATIONS ON TAX PREPARERS WHO CLAIM THE EITC, CHILD TAX CREDIT (CTC), ADDITIONAL CHILD TAX CREDIT (ACTC), AND AMERICAN OPPORTUNITY TAX CREDIT (AOTC) FOR THEIR CLIENTS. THE IRS RESPONDED BY INSTITUTING RIGOROUS DUE DILIGENCE STANDARDS AND TRAINING PROTOCOLS TO ENSURE COMPLIANCE.

TAX PREPARERS MUST COMPLETE ANNUAL EITC DUE DILIGENCE TRAINING AND PASS A KNOWLEDGE TEST TO DEMONSTRATE THEIR UNDERSTANDING OF ELIGIBILITY CRITERIA, DOCUMENTATION REQUIREMENTS, AND PROPER PROCEDURES FOR CLAIMING THE CREDIT. FAILURE TO COMPLY WITH THESE REQUIREMENTS CAN RESULT IN SIGNIFICANT PENALTIES, INCLUDING FINES UP TO \$545 PER FAILURE, EMPHASIZING THE SERIOUSNESS WITH WHICH THE IRS ENFORCES THESE RULES.

## WHY EITC DUE DILIGENCE TRAINING MATTERS

THE EITC IS A POWERFUL TOOL FOR REDUCING POVERTY AND ENCOURAGING WORK, BUT IT IS ALSO ONE OF THE MOST ERROR-PRONE TAX CREDITS DUE TO ITS COMPLEX ELIGIBILITY RULES AND FREQUENT CHANGES IN TAX LAW. THE IRS ESTIMATES THAT IMPROPER EITC PAYMENTS ACCOUNT FOR BILLIONS OF DOLLARS ANNUALLY, REPRESENTING A SUBSTANTIAL PORTION OF THE "TAX GAP"—THE DIFFERENCE BETWEEN TAXES OWED AND TAXES PAID.

EITC DUE DILIGENCE TRAINING SERVES MULTIPLE PURPOSES:

- **ACCURACY IMPROVEMENT:** IT HELPS PREPARERS UNDERSTAND THE NUANCES OF EITC ELIGIBILITY, SUCH AS INCOME THRESHOLDS, QUALIFYING CHILDREN RULES, AND RESIDENCY REQUIREMENTS.
- **FRAUD PREVENTION:** TRAINING EDUCATES PREPARERS ON SPOTTING POTENTIAL RED FLAGS AND AVOIDING AGGRESSIVE TAX POSITIONS THAT COULD LEAD TO FRAUDULENT CLAIMS.
- **LEGAL COMPLIANCE:** STAYING UPDATED WITH IRS GUIDELINES PROTECTS PREPARERS FROM PENALTIES AND SANCTIONS.
- **CLIENT PROTECTION:** ENSURES TAXPAYERS RECEIVE THE CORRECT CREDIT AMOUNT AND AVOID AUDITS OR PENALTIES STEMMING FROM INACCURATE FILINGS.

## CORE COMPONENTS OF EITC DUE DILIGENCE TRAINING

- INCOME LIMITS BASED ON FILING STATUS AND NUMBER OF QUALIFYING CHILDREN.
- DEFINITION OF QUALIFYING CHILDREN, INCLUDING RELATIONSHIP, AGE, RESIDENCY, AND JOINT RETURN TESTS.
- INVESTMENT INCOME LIMITATIONS.

- RULES FOR TAXPAYERS WITHOUT QUALIFYING CHILDREN.

TRAINING MODULES TYPICALLY PROVIDE CASE STUDIES AND REAL-WORLD EXAMPLES TO HELP PREPARERS NAVIGATE THESE COMPLEXITIES.

## DOCUMENTATION AND RECORDKEEPING REQUIREMENTS

THE IRS MANDATES THAT PREPARERS RETAIN SPECIFIC RECORDS TO DEMONSTRATE DUE DILIGENCE. TRAINING INCLUDES GUIDANCE ON:

- GATHERING AND VERIFYING CLIENT INFORMATION, SUCH AS SOCIAL SECURITY NUMBERS AND PROOF OF RESIDENCY FOR CHILDREN.
- MAINTAINING COPIES OF WORKSHEETS AND CLIENT QUESTIONNAIRES USED TO DETERMINE ELIGIBILITY.
- DOCUMENTING CONVERSATIONS AND DECISIONS MADE DURING THE PREPARATION PROCESS.

PROPER DOCUMENTATION NOT ONLY ENSURES COMPLIANCE BUT ALSO SERVES AS A DEFENSE IN CASE OF AUDITS OR DISPUTES.

## ETHICAL CONSIDERATIONS AND PROFESSIONAL RESPONSIBILITY

BEYOND TECHNICAL KNOWLEDGE, EITC DUE DILIGENCE TRAINING EMPHASIZES THE ETHICAL OBLIGATIONS OF TAX PREPARERS. THIS INCLUDES:

- AVOIDING AGGRESSIVE OR FRAUDULENT CLAIMS TO MAXIMIZE REFUNDS.
- COMMUNICATING CLEARLY WITH CLIENTS ABOUT ELIGIBILITY AND POTENTIAL LIMITATIONS.
- MAINTAINING CONFIDENTIALITY AND PROFESSIONAL INTEGRITY.
