The devil's false gospel reverses the order of things. Under the false gospel preached in most churches, Jesus does

not choose his elect for salvation, instead all men have a free will to choose Jesus. Instead of God choosing man, man chooses God. This mythology is not supported by the bible. It is at the heart of a devilish conspiracy against God and man. The free will anti-gospel denies the sovereignty of God and blasphemously makes God out to be a liar. The free will gospel is a heathen gospel that has a god, but that god is not the God of the bible. The calling of the true Jesus is effectual; all who are chosen for salvation will believe in him. John 6:37-40. The free will gospel has a false Jesus who only offers the possibility of salvation, with no assurance. The scriptures warn about such a false Jesus. 2 Corinthians 11:4.
