MOUNTING THE FAN

3. CONNECTING THE FAN TO THE MOUNTING BRACKET WITH THE DOWNROD OR FLUSH MOUNT KIT, DEPENDING ON YOUR CEILING HEIGHT.

WIRING YOUR FAN SAFELY

- **SUMMER MODE:** FAN BLADES ROTATE COUNTERCLOCKWISE TO CREATE A COOLING BREEZE.
- **WINTER MODE:** FAN BLADES ROTATE CLOCKWISE TO CIRCULATE WARM AIR TRAPPED NEAR THE CEILING.

LIGHTING FEATURES

IF YOUR CASA VIEJA FAN INCLUDES AN INTEGRATED LIGHT KIT, THE MANUAL WILL GUIDE YOU ON HOW TO OPERATE AND REPLACE BULBS SAFELY. SOME MODELS SUPPORT DIMMABLE LIGHTS, AND THE MANUAL MAY INCLUDE INSTRUCTIONS ON COMPATIBLE DIMMER SWITCHES.

MAINTAINING YOUR CASA VIEJA CEILING FAN

CLEANING YOUR FAN

TIGHTENING AND LUBRICATION

TROUBLESHOOTING COMMON ISSUES WITH CASA VIEJA FANS
