HEALTHCARE ORGANIZATIONS MIGHT ALSO BENEFIT FROM ANALYTICS DASHBOARDS POWERED BY HEALTHSTREAM, TRACKING COMPETENCY TRENDS OVER TIME AND CORRELATING ASSESSMENT PERFORMANCE WITH CLINICAL OUTCOMES. SUCH DATA-DRIVEN INSIGHTS COULD REFINE EDUCATIONAL STRATEGIES AND SUPPORT CONTINUOUS QUALITY IMPROVEMENT IN MEDICATION SAFETY.
