WHY A STRONG OCCUPATIONAL THERAPY RESUME MATTERS

IN THE HEALTHCARE FIELD, YOUR RESUME IS OFTEN THE FIRST IMPRESSION YOU MAKE ON POTENTIAL EMPLOYERS. OCCUPATIONAL THERAPY IS A SPECIALIZED PROFESSION THAT REQUIRES A DISTINCT SET OF SKILLS AND CERTIFICATIONS, AND YOUR RESUME NEEDS TO COMMUNICATE THESE CLEARLY AND EFFECTIVELY. A WELL-CRAFTED RESUME NOT ONLY SHOWCASES YOUR CLINICAL EXPERTISE BUT ALSO YOUR ABILITY TO COLLABORATE WITH PATIENTS, FAMILIES, AND MULTIDISCIPLINARY TEAMS.

EMPLOYERS TYPICALLY LOOK FOR RESUMES THAT DEMONSTRATE CLINICAL COMPETENCE, RELEVANT CERTIFICATIONS LIKE THE NBCOT (NATIONAL BOARD FOR CERTIFICATION IN OCCUPATIONAL THERAPY), AND A CLEAR RECORD OF PATIENT OUTCOMES AND PROFESSIONAL DEVELOPMENT. WITH MANY APPLICANTS VYING FOR LIMITED POSITIONS, STANDING OUT WITH A POLISHED, TARGETED RESUME CAN MAKE ALL THE DIFFERENCE.

KEY COMPONENTS OF OCCUPATIONAL THERAPY RESUME EXAMPLES

TO MAKE YOUR RESUME RESONATE WITH HIRING MANAGERS IN HEALTHCARE, IT'S IMPORTANT TO FOCUS ON SEVERAL CORE SECTIONS:

1. CONTACT INFORMATION AND PROFESSIONAL SUMMARY

START WITH YOUR FULL NAME, PHONE NUMBER, EMAIL, AND LINKEDIN PROFILE IF YOU HAVE ONE. FOLLOWING THIS, INCLUDE A PROFESSIONAL SUMMARY—A BRIEF PARAGRAPH THAT HIGHLIGHTS YOUR EXPERIENCE, SKILLS, AND WHAT YOU BRING TO THE ROLE. THIS SUMMARY SHOULD BE CUSTOMIZED FOR EACH APPLICATION TO ALIGN WITH THE JOB DESCRIPTION.

EXAMPLE:

"COMPASSIONATE AND DEDICATED OCCUPATIONAL THERAPIST WITH 5+ YEARS OF EXPERIENCE PROVIDING PATIENT-CENTERED CARE IN OUTPATIENT AND REHABILITATION SETTINGS. SKILLED IN DEVELOPING INDIVIDUALIZED TREATMENT PLANS, CONDUCTING ASSESSMENTS, AND FOSTERING PATIENT INDEPENDENCE."

2. LICENSES AND CERTIFICATIONS

BECAUSE OCCUPATIONAL THERAPY IS A REGULATED PROFESSION, IT'S CRUCIAL TO LIST ALL RELEVANT LICENSES AND CERTIFICATIONS CLEARLY. THIS TYPICALLY INCLUDES YOUR STATE LICENSE, NBCOT CERTIFICATION, AND ANY SPECIALIZED CREDENTIALS SUCH AS CERTIFICATIONS IN PEDIATRIC THERAPY OR HAND THERAPY.

3. PROFESSIONAL EXPERIENCE

DETAIL YOUR WORK HISTORY IN REVERSE CHRONOLOGICAL ORDER, EMPHASIZING ROLES THAT ARE MOST RELEVANT TO

OCCUPATIONAL THERAPY. USE BULLET POINTS TO DESCRIBE YOUR RESPONSIBILITIES AND ACHIEVEMENTS, FOCUSING ON QUANTIFIABLE RESULTS WHEN POSSIBLE.

EXAMPLE BULLET POINTS:

- DEVELOPED INDIVIDUALIZED TREATMENT PLANS FOR 20+ PATIENTS WEEKLY, RESULTING IN A 30% IMPROVEMENT IN PATIENT FUNCTIONAL OUTCOMES.
- COLLABORATED WITH INTERDISCIPLINARY TEAMS INCLUDING PHYSICAL THERAPISTS, SPEECH THERAPISTS, AND SOCIAL WORKERS TO COORDINATE COMPREHENSIVE CARE.
- CONDUCTED DETAILED PATIENT ASSESSMENTS TO IDENTIFY PHYSICAL AND COGNITIVE BARRIERS TO DAILY LIVING ACTIVITIES.

4. EDUCATION

LIST YOUR DEGREES, STARTING WITH THE MOST RECENT. INCLUDE THE NAME OF THE INSTITUTION, DEGREE EARNED (E.G., MASTER OF OCCUPATIONAL THERAPY), AND GRADUATION DATE. IF YOU HAVE RELEVANT COURSEWORK OR HONORS, YOU CAN ADD THOSE AS WELL.

5. SKILLS SECTION

HIGHLIGHT BOTH HARD AND SOFT SKILLS RELEVANT TO OCCUPATIONAL THERAPY. THIS CAN INCLUDE CLINICAL SKILLS LIKE THERAPEUTIC TECHNIQUES, ASSISTIVE TECHNOLOGY PROFICIENCY, AND PATIENT ASSESSMENT, AS WELL AS SOFT SKILLS SUCH AS COMMUNICATION, EMPATHY, AND TEAMWORK.

HOW TO TAILOR OCCUPATIONAL THERAPY RESUME EXAMPLES FOR DIFFERENT SETTINGS

OCCUPATIONAL THERAPISTS WORK IN VARIOUS ENVIRONMENTS—FROM HOSPITALS AND OUTPATIENT CLINICS TO SCHOOLS AND HOME HEALTH CARE. TAILORING YOUR RESUME TO FIT THE SPECIFIC SETTING CAN INCREASE YOUR CHANCES OF LANDING AN INTERVIEW.

RESUME TIPS FOR HOSPITAL-BASED OCCUPATIONAL THERAPISTS

WHEN APPLYING TO HOSPITALS, EMPHASIZE EXPERIENCE WITH ACUTE CARE, REHABILITATION, AND INTERDISCIPLINARY TEAMWORK. HIGHLIGHT YOUR ABILITY TO WORK IN FAST-PACED ENVIRONMENTS AND YOUR FAMILIARITY WITH ELECTRONIC HEALTH RECORDS (EHR).

EXAMPLE:

“SUCCESSFULLY MANAGED CASELOADS OF 15+ PATIENTS IN A HIGH-VOLUME HOSPITAL SETTING, UTILIZING EHR SYSTEMS TO DOCUMENT PATIENT PROGRESS AND COORDINATE CARE.”

RESUME TIPS FOR PEDIATRIC OCCUPATIONAL THERAPY ROLES

FOR THOSE TARGETING PEDIATRIC THERAPY POSITIONS, FOCUS ON EXPERIENCE WITH CHILD DEVELOPMENT, PLAY-BASED

INTERVENTIONS, AND COLLABORATION WITH FAMILIES AND EDUCATORS.

EXAMPLE:

“IMPLEMENTED SENSORY INTEGRATION TECHNIQUES FOR CHILDREN WITH DEVELOPMENTAL DELAYS, LEADING TO MEASURABLE IMPROVEMENTS IN FINE MOTOR SKILLS AND SOCIAL INTERACTION.”

RESUME TIPS FOR HOME HEALTH OCCUPATIONAL THERAPISTS

HOME HEALTH THERAPISTS SHOULD UNDERScore THEIR ADAPTABILITY, ABILITY TO WORK INDEPENDENTLY, AND EXPERIENCE CREATING TREATMENT PLANS IN PATIENTS’ HOME ENVIRONMENTS.

EXAMPLE:

“PROVIDED IN-HOME THERAPY SERVICES TO ELDERLY PATIENTS POST-SURGERY, ENHANCING MOBILITY AND FUNCTIONAL INDEPENDENCE THROUGH CUSTOMIZED REHABILITATION PROGRAMS.”

COMMON MISTAKES TO AVOID IN OCCUPATIONAL THERAPY RESUME EXAMPLES

EVEN THE MOST QUALIFIED CANDIDATES CAN STUMBLE WHEN THEIR RESUME CONTAINS AVOIDABLE ERRORS. HERE ARE SOME PITFALLS TO WATCH OUT FOR:

- **BEING TOO GENERIC:** AVOID USING VAGUE DESCRIPTIONS. INSTEAD, PROVIDE SPECIFIC EXAMPLES OF YOUR IMPACT AND SKILLS.

- **OVERLOADING WITH JARGON:** WHILE CLINICAL TERMS ARE IMPORTANT, ENSURE YOUR RESUME REMAINS READABLE AND ACCESSIBLE.
- **NEGLECTING FORMATTING:** A CLUTTERED OR INCONSISTENT LAYOUT CAN DISTRACT HIRING MANAGERS. KEEP FORMATTING CLEAN AND PROFESSIONAL.

PROFESSIONAL EXPERIENCE

OCCUPATIONAL THERAPIST | RIVERSIDE REHABILITATION CENTER | JUNE 2019 – PRESENT

- CONDUCT COMPREHENSIVE ASSESSMENTS FOR ADULT PATIENTS RECOVERING FROM STROKE AND TRAUMATIC INJURIES.
- DESIGN AND IMPLEMENT PERSONALIZED TREATMENT PLANS FOCUSING ON IMPROVING ACTIVITIES OF DAILY LIVING (ADLS).
- COLLABORATE WITH MULTIDISCIPLINARY TEAMS TO ENSURE HOLISTIC PATIENT CARE AND TIMELY DISCHARGE PLANNING.
- DOCUMENT PATIENT PROGRESS ACCURATELY IN COMPLIANCE WITH HIPAA AND ORGANIZATIONAL POLICIES.

THIS EXAMPLE HIGHLIGHTS RELEVANT DUTIES AND SHOWCASES THE CANDIDATE'S ROLE IN BOTH DIRECT PATIENT CARE AND TEAMWORK, ESSENTIAL ELEMENTS THAT EMPLOYERS SEEK.

BOOSTING YOUR RESUME WITH VOLUNTEER WORK AND CONTINUING EDUCATION

INCLUDING VOLUNTEER EXPERIENCES RELATED TO OCCUPATIONAL THERAPY OR HEALTHCARE CAN STRENGTHEN YOUR RESUME, ESPECIALLY IF YOU'RE A NEW GRADUATE. LIKewise, LISTING WORKSHOPS, SEMINARS, OR COURSES YOU'VE COMPLETED SHOWS YOUR COMMITMENT TO PROFESSIONAL GROWTH.

EXAMPLES MIGHT INCLUDE:

- VOLUNTEER OCCUPATIONAL THERAPIST AT COMMUNITY HEALTH CLINIC
- COMPLETED CONTINUING EDUCATION COURSE ON ADVANCED THERAPEUTIC TECHNIQUES FOR NEUROLOGICAL DISORDERS

THESE ADDITIONS DEMONSTRATE PASSION AND INITIATIVE, QUALITIES HIGHLY VALUED IN HEALTHCARE PROFESSIONALS.

FINAL THOUGHTS ON WRITING AN EFFECTIVE OCCUPATIONAL THERAPY RESUME

CREATING A RESUME THAT RESONATES WITH EMPLOYERS IN OCCUPATIONAL THERAPY REQUIRES MORE THAN LISTING YOUR JOB HISTORY. IT DEMANDS THOUGHTFUL PRESENTATION OF YOUR SKILLS, ACHIEVEMENTS, AND PROFESSIONAL GROWTH IN WAYS THAT ALIGN WITH THE DEMANDS OF THE POSITION. USING OCCUPATIONAL THERAPY RESUME EXAMPLES AS INSPIRATION CAN HELP GUIDE YOUR STRUCTURE AND CONTENT, BUT ALWAYS REMEMBER TO PERSONALIZE YOUR RESUME TO TELL YOUR UNIQUE STORY.

BY FOCUSING ON CLARITY, RELEVANCE, AND PROFESSIONALISM, YOUR RESUME CAN OPEN DOORS TO EXCITING OPPORTUNITIES IN THIS REWARDING CAREER. KEEP REFINING YOUR DOCUMENT AS YOU GAIN EXPERIENCE, AND DON'T HESITATE TO SEEK FEEDBACK FROM MENTORS OR RESUME PROFESSIONALS TO ENSURE YOUR RESUME REPRESENTS YOUR BEST SELF.

WHAT ARE KEY SECTIONS TO INCLUDE IN AN OCCUPATIONAL THERAPY RESUME?

KEY SECTIONS IN AN OCCUPATIONAL THERAPY RESUME INCLUDE CONTACT INFORMATION, PROFESSIONAL SUMMARY, LICENSES AND CERTIFICATIONS, EDUCATION, WORK EXPERIENCE, SKILLS, AND PROFESSIONAL AFFILIATIONS.

HOW CAN I HIGHLIGHT MY CLINICAL EXPERIENCE IN AN OCCUPATIONAL THERAPY RESUME?

YOU CAN HIGHLIGHT CLINICAL EXPERIENCE BY DETAILING YOUR RESPONSIBILITIES, TYPES OF PATIENTS TREATED, SPECIFIC INTERVENTIONS USED, AND MEASURABLE OUTCOMES IN THE WORK EXPERIENCE SECTION.

SHOULD I INCLUDE VOLUNTEER WORK IN MY OCCUPATIONAL THERAPY RESUME?

YES, INCLUDING RELEVANT VOLUNTEER WORK CAN DEMONSTRATE ADDITIONAL SKILLS AND DEDICATION TO THE FIELD, ESPECIALLY IF YOU HAVE LIMITED PAID EXPERIENCE.

WHAT KEYWORDS SHOULD I USE IN AN OCCUPATIONAL THERAPY RESUME TO PASS APPLICANT TRACKING SYSTEMS (ATS)?

USE KEYWORDS SUCH AS 'PATIENT ASSESSMENT,' 'TREATMENT PLANNING,' 'REHABILITATION,' 'ADL TRAINING,' 'THERAPEUTIC INTERVENTIONS,' AND SPECIFIC SOFTWARE OR CERTIFICATIONS RELEVANT TO OCCUPATIONAL THERAPY.

HOW LONG SHOULD AN OCCUPATIONAL THERAPY RESUME BE?

AN OCCUPATIONAL THERAPY RESUME SHOULD IDEALLY BE ONE TO TWO PAGES LONG, FOCUSING ON THE MOST RELEVANT AND RECENT EXPERIENCES.

IS IT BETTER TO USE A FUNCTIONAL OR CHRONOLOGICAL FORMAT FOR AN OCCUPATIONAL THERAPY RESUME?

A CHRONOLOGICAL FORMAT IS GENERALLY PREFERRED AS IT CLEARLY OUTLINES YOUR CAREER PROGRESSION AND CLINICAL EXPERIENCE, BUT A FUNCTIONAL FORMAT CAN BE USED IF YOU ARE CHANGING CAREERS OR HAVE GAPS IN EMPLOYMENT.

HOW CAN I DEMONSTRATE SOFT SKILLS ON AN OCCUPATIONAL THERAPY RESUME?

DEMONSTRATE SOFT SKILLS LIKE COMMUNICATION, EMPATHY, TEAMWORK, AND PROBLEM-SOLVING BY INCORPORATING EXAMPLES AND ACHIEVEMENTS THAT REFLECT THESE QUALITIES WITHIN YOUR WORK EXPERIENCE DESCRIPTIONS.

SHOULD I INCLUDE CONTINUING EDUCATION ON MY OCCUPATIONAL THERAPY RESUME?

YES, LISTING RELEVANT CONTINUING EDUCATION COURSES AND WORKSHOPS SHOWS COMMITMENT TO PROFESSIONAL DEVELOPMENT AND STAYING CURRENT IN THE FIELD.

HOW DO I TAILOR MY OCCUPATIONAL THERAPY RESUME FOR A PEDIATRIC POSITION?

FOCUS ON PEDIATRIC-RELATED EXPERIENCE, SKILLS, AND CERTIFICATIONS, SUCH AS WORKING WITH CHILDREN, KNOWLEDGE OF DEVELOPMENTAL MILESTONES, AND PEDIATRIC THERAPEUTIC TECHNIQUES.

CAN I INCLUDE PERSONAL INTERESTS ON MY OCCUPATIONAL THERAPY RESUME?

ONLY INCLUDE PERSONAL INTERESTS IF THEY ARE RELEVANT TO OCCUPATIONAL THERAPY OR DEMONSTRATE TRANSFERABLE SKILLS; OTHERWISE, IT IS BETTER TO KEEP THE RESUME PROFESSIONAL AND FOCUSED.

ADDITIONAL RESOURCES

OCCUPATIONAL THERAPY RESUME EXAMPLES: CRAFTING A STANDOUT PROFESSIONAL PROFILE

OCCUPATIONAL THERAPY RESUME EXAMPLES SERVE AS A VITAL RESOURCE FOR PRACTITIONERS AIMING TO SECURE POSITIONS IN A HIGHLY SPECIALIZED AND COMPETITIVE HEALTHCARE FIELD. AS OCCUPATIONAL THERAPY CONTINUES TO EVOLVE, SO DOES THE DEMAND FOR RESUMES THAT NOT ONLY REFLECT TECHNICAL PROFICIENCY BUT ALSO HIGHLIGHT INTERPERSONAL SKILLS, PATIENT-CENTERED CARE, AND MULTIDISCIPLINARY COLLABORATION. AN EFFECTIVE OCCUPATIONAL THERAPY RESUME BALANCES CLINICAL EXPERTISE WITH A DEMONSTRATION OF SOFT SKILLS, CERTIFICATIONS, AND CONTINUING EDUCATION, PRESENTING A COMPREHENSIVE PICTURE TAILORED TO HIRING MANAGERS AND RECRUITERS.

TYPICALLY, AN OCCUPATIONAL THERAPY RESUME IS DIVIDED INTO THE FOLLOWING CORE SECTIONS:

- **CONTACT INFORMATION:** CLEAR AND PROFESSIONAL, INCLUDING NAME, PHONE NUMBER, EMAIL, AND RELEVANT LICENSING DETAILS.
- **PROFESSIONAL SUMMARY OR OBJECTIVE:** A CONCISE STATEMENT HIGHLIGHTING THE THERAPIST'S EXPERIENCE, SPECIALTIES, AND CAREER GOALS.
- **LICENSES AND CERTIFICATIONS:** ESSENTIAL CREDENTIALS SUCH AS STATE LICENSES, NBCOT CERTIFICATION, CPR, AND ANY SPECIALTY CERTIFICATIONS LIKE HAND THERAPY OR PEDIATRICS.
- **PROFESSIONAL EXPERIENCE:** DETAILED ACCOUNTS OF CLINICAL ROLES, SHOWCASING RESPONSIBILITIES, PATIENT POPULATIONS, AND OUTCOMES.
- **EDUCATION:** DEGREE INFORMATION, INCLUDING INSTITUTION NAMES, GRADUATION DATES, AND RELEVANT COURSEWORK OR HONORS.
- **SKILLS:** BOTH HARD SKILLS (E.G., THERAPEUTIC TECHNIQUES, ASSESSMENT TOOLS) AND SOFT SKILLS (E.G., COMMUNICATION, EMPATHY).
- **CONTINUING EDUCATION AND PROFESSIONAL DEVELOPMENT:** WORKSHOPS, SEMINARS, OR ADVANCED TRAINING THAT DEMONSTRATE ONGOING COMMITMENT.

AN OCCUPATIONAL THERAPY RESUME EXAMPLE THAT INTEGRATES THESE SECTIONS EFFECTIVELY CAN DRAMATICALLY IMPROVE A CANDIDATE'S VISIBILITY IN APPLICANT TRACKING SYSTEMS (ATS) AND IN THE EYES OF HIRING MANAGERS.

PROFESSIONAL SUMMARY EXAMPLES: SETTING THE TONE

THE PROFESSIONAL SUMMARY IS OFTEN THE FIRST NARRATIVE ELEMENT THAT RECRUITERS READ. IT MUST BE SUCCINCT YET IMPACTFUL. FOR OCCUPATIONAL THERAPISTS, A COMPELLING SUMMARY MIGHT INCLUDE YEARS OF EXPERIENCE, THE TYPES OF SETTINGS WORKED IN (E.G., PEDIATRIC CLINICS, REHABILITATION CENTERS), AND SPECIFIC THERAPEUTIC TECHNIQUES MASTERED.

FOR INSTANCE:

"LICENSED OCCUPATIONAL THERAPIST WITH OVER 5 YEARS OF EXPERIENCE SPECIALIZING IN PEDIATRIC NEURODEVELOPMENTAL DISORDERS. SKILLED IN CREATING INDIVIDUALIZED TREATMENT PLANS AND COLLABORATING WITH INTERDISCIPLINARY TEAMS TO ENHANCE PATIENT OUTCOMES."

THIS EXAMPLE ILLUSTRATES HOW OCCUPATIONAL THERAPY RESUME EXAMPLES INCORPORATE RELEVANT KEYWORDS LIKE "LICENSED," "TREATMENT PLANS," AND "INTERDISCIPLINARY TEAMS," WHICH ALIGN WITH ATS ALGORITHMS AND INDUSTRY EXPECTATIONS.

HIGHLIGHTING EXPERIENCE: QUANTIFYING IMPACT

LICENSES AND CERTIFICATIONS: WHY THEY MATTER

IN THE OCCUPATIONAL THERAPY FIELD, LICENSES AND CERTIFICATIONS ARE NON-NEGOTIABLE COMPONENTS OF A RESUME. EMPLOYERS PRIORITIZE CANDIDATES WHO MEET REGULATORY REQUIREMENTS AND POSSESS ADVANCED CREDENTIALS THAT SUGGEST A COMMITMENT TO PROFESSIONAL GROWTH.

THE NATIONAL BOARD FOR CERTIFICATION IN OCCUPATIONAL THERAPY (NBCOT) CERTIFICATION IS OFTEN A CRITICAL INCLUSION. ADDITIONALLY, STATE LICENSURE MUST BE CLEARLY STATED, PREFERABLY WITH LICENSE NUMBERS AND EXPIRATION DATES TO REASSURE EMPLOYERS OF COMPLIANCE.

SPECIALTY CERTIFICATIONS, SUCH AS CERTIFIED HAND THERAPIST (CHT) OR CERTIFICATIONS IN SENSORY INTEGRATION, SHOULD BE PROMINENTLY FEATURED, AS THEY CAN DIFFERENTIATE CANDIDATES AND OPEN DOORS TO NICHE ROLES.

FORMATTING TIPS FOR MAXIMUM READABILITY AND ATS COMPATIBILITY

THE DESIGN AND FORMATTING OF AN OCCUPATIONAL THERAPY RESUME CAN SIGNIFICANTLY INFLUENCE ITS EFFECTIVENESS. GIVEN THAT MANY HEALTHCARE EMPLOYERS UTILIZE ATS SOFTWARE, THE INCLUSION OF RELEVANT KEYWORDS AND SIMPLE FORMATTING IS CRUCIAL.

IMPORTANT FORMATTING CONSIDERATIONS INCLUDE:

- **USE OF STANDARD FONTS:** FONTS LIKE ARIAL, CALIBRI, OR TIMES NEW ROMAN ENHANCE READABILITY AND REDUCE PARSING ERRORS.
- **CONSISTENT LAYOUT:** UNIFORM BULLET POINTS, SPACING, AND SECTION HEADERS HELP RECRUITERS SCAN THE DOCUMENT EFFICIENTLY.
- **KEYWORD INTEGRATION:** EMBEDDING INDUSTRY-SPECIFIC TERMS SUCH AS “PATIENT-CENTERED CARE,” “THERAPEUTIC INTERVENTIONS,” AND “CLINICAL DOCUMENTATION” INCREASES ATS RANKING.

- **LENGTH:** IDEALLY, OCCUPATIONAL THERAPY RESUMES SHOULD BE ONE TO TWO PAGES, FOCUSING ON THE MOST RELEVANT AND RECENT EXPERIENCE.

OCCUPATIONAL THERAPY RESUME EXAMPLES THAT FOLLOW THESE GUIDELINES TEND TO PERFORM BETTER BOTH IN AUTOMATED SCREENINGS AND HUMAN REVIEWS.

SOFT SKILLS: THE SUBTLE DIFFERENTIATORS

WHILE CLINICAL EXPERTISE FORMS THE BACKBONE OF AN OCCUPATIONAL THERAPY RESUME, SOFT SKILLS OFTEN TIP THE SCALES DURING FINAL HIRING DECISIONS. EMPATHY, COMMUNICATION, TEAMWORK, AND PROBLEM-SOLVING ARE CRITICAL FOR THERAPISTS WHO REGULARLY INTERACT WITH PATIENTS AND FAMILIES.

INCORPORATING EXAMPLES OF THESE SKILLS CAN BE ACHIEVED THROUGH SPECIFIC JOB DESCRIPTIONS OR A DEDICATED SKILLS SECTION. FOR EXAMPLE:

- “DEMONSTRATED EMPATHY AND ACTIVE LISTENING TO BUILD TRUST WITH PATIENTS UNDERGOING LONG-TERM REHABILITATION.”
- “LED PATIENT EDUCATION SESSIONS THAT IMPROVED ADHERENCE TO THERAPEUTIC REGIMENS.”
- “FACILITATED INTERDISCIPLINARY TEAM MEETINGS TO COORDINATE COMPREHENSIVE CARE PLANS.”

SUCH DESCRIPTIONS ADD DEPTH TO A RESUME AND ILLUSTRATE THE CANDIDATE’S HOLISTIC APPROACH TO OCCUPATIONAL THERAPY.

COMPARING ENTRY-LEVEL VS. EXPERIENCED OCCUPATIONAL THERAPY RESUMES

- RELEVANT COURSEWORK SUCH AS ANATOMY, KINESIOLOGY, AND THERAPEUTIC TECHNIQUES.
- VOLUNTEER EXPERIENCES RELATED TO HEALTHCARE SETTINGS.

IN CONTRAST, SEASONED THERAPISTS HIGHLIGHT:

- YEARS OF CLINICAL PRACTICE AND DIVERSE PATIENT POPULATIONS SERVED.

- LEADERSHIP ROLES, SUCH AS SUPERVISING AIDES OR MANAGING CASELOADS.
- CONTRIBUTIONS TO PROGRAM DEVELOPMENT OR RESEARCH INITIATIVES.

BOTH TYPES OF RESUMES BENEFIT FROM TAILORED KEYWORDS AND QUANTIFIABLE ACHIEVEMENTS BUT REQUIRE DIFFERENT EMPHASES TO RESONATE WITH HIRING MANAGERS.

LEVERAGING TECHNOLOGY: DIGITAL PORTFOLIOS AND LINKEDIN INTEGRATION

CANDIDATES CAN SHOWCASE:

- VIDEO DEMONSTRATIONS OF THERAPEUTIC TECHNIQUES.
- PUBLISHED ARTICLES OR PRESENTATIONS ON OCCUPATIONAL THERAPY TOPICS.
- RECOMMENDATIONS AND ENDORSEMENTS FROM COLLEAGUES AND SUPERVISORS.

THIS APPROACH NOT ONLY ENRICHES THE RESUME BUT ALSO SIGNALS TECH-SAVVINESS AND PROACTIVE CAREER MANAGEMENT, QUALITIES VALUED IN CONTEMPORARY HEALTHCARE SETTINGS.
