- 4. CONSTITUTIONAL INTERPRETATION: ACTIVITIES DISTINGUISHING ORIGINALISM FROM LIVING CONSTITUTIONALISM.
- 5. Mock Trials and Role-Play: Scripted scenarios encouraging students to apply judicial reasoning.
